## **CALL TO ORDER:**

The August 18, 2020 meeting of the Board of Supervisors of Palmyra Township, Pike County, PA was called to order at 7:25 PM at the Township Building, Paupack, PA with the following members present: Simons, Ehrhardt and Coutts. Also present for the Township was Solicitor Waldron.

# **MINUTES/BILLS/RECEIPTS:**

On motion by Mr. Coutts, seconded by Mr. Ehrhardt, and unanimously carried, the minutes of the August 4, 2020 meeting were approved. Bills in the amount of \$8,893.24 were approved for payment and receipts in the amount of \$22,676.16 were reported with a list of each on file.

## **CARGILL SALT CONTRACT**

On a motion by Mr. Erhardt, seconded by Mr. Coutts and unanimously carried Chairman Simons signed the contract between Cargill and the township. Deicer was quoted at \$89.00 a ton and the township had requested 125 tons for the 2020-2021 winter season.

## **CABEL MINOR SUBDIVISION**

The Supervisors revisited the matter concerning the Cabel minor subdivision. They had approved the plan at the August 4, 2020 meeting subject to county comments. Pike County Office of Community Planning had submitted their letter taking no exception to the plan and accordingly the Supervisors re-approved it to reflect the date of actual signing, being August 18, 2020.

#### **SOLICITOR'S REPORT:**

Mr. Waldron reported on the following:

## **IRISH HEARING – ZONING VIOLATION**

Solicitor Waldron advised the Supervisors the new date for the Irish hearing at the Court of Common Pleas level has been scheduled for September 2, 2020 at 2:00 PM. Solicitor Waldron and Zoning Officer Manter will both attend the hearing.

## **ROUTE 6 TIRE – ZONING VIOLATION**

Solicitor Waldron reported that Route 6 Tire is in violation of a Stipulation they entered with the township. Accordingly, he will be taking the matter to Pike County Court of Common Pleas.

#### WALLACE – ZONING VIOLATION

Solicitor Waldron reported that in discussions with Zoning Officer Manter he was advised that Fabio Wallace has not followed through with the agreed upon terms set at a previous hearing. Accordingly, he will be taking the matter back to the Magistrate.

## **ZULLO – SEWAGE EASEMENT AGREEMENT**

Solicitor Waldron presented a proposed sewage easement agreement for Tracy Zullo. After discussion it was decided to table the matter until SEO Martin can be consulted on the matter.

## PAUPACK STREET - HAWLEY BOROUGH

The township received a letter from Hawley Borough asking that a request be made to Eastern Propane to participate financially in the repaving of Paupack Street due to the heavy volume of truck traffic from their business. They acknowledged that Paupack Street is located with the bounds of Hawley Borough was
